#### **REPORTS**

# Superintendent

Mr. Eric Briggs, Superintendent, reported on the following items:

- Yesterday, myself, with three other superintendents had the opportunity to meet with Representative Sonney. Two areas of focus with this advocacy effort were around cyber-charter school expenses and special education costs.
- Mr. Darryl Jannone has already begun the planning process for our safety trainings districtwide for the 2019-2020 school year. We are looking to take the next steps in our ALICE training and other training areas. Safety tasks planed for the spring of this year and next year include:
  - Establishing and practicing getting students to evacuation sites should a threat be present in one or more school buildings
  - Having select students participate in ALICE Training
  - Successful completion of a lockdown drill
  - Participation in the spring Bradford County Emergency Management Drill
  - Successful completion of our Risk and Vulnerability Assessment through the PSP
- Our high school Tier I PBIS Team continues to prepare for the launching of our high school "school wide initiative" at the start of the 2019-20120 school year. Tomorrow this group will lead the professional learning at our high school as we look at setting up the program to meet student needs from an academic, behavioral, and social/emotional perspective.
- Next week we are excited to host the PMEA Regional Chorus festivities at the Canton Jr/Sr High School. We anticipate over 200 students participating in this regional program. Mrs. Colleen Kinney

has spent many hours preparing to host this event on behalf of PMEA, and we are excited to have these students on campus as they look to secure a position in the statewide competition.

- This past week our spring sports season began. I want to personally wish all the spring athletic programs the best of luck in all their competitions throughout the spring sports season.
- Last week we held a cyber-safety meeting for all parents in the CASD on how families can better support their students to ensure they are safe while participating in the world of social media. We were very pleased with the number of families that showed up to our elementary presentation.
- I wanted to personally congratulate our elementary and high school K'NEX teams as they placed first in the regional K'NEX competition hosted by Penn College and conducted by BLaST IU #17. Both teams took first place in the competition and will compete in the state competition later this spring in Harrisburg. Elementary students include Ethan May, Aaron Seeley, Fayth Kilbourn, and Alexis McRoberts. High school team members include Camille McRoberts, Natalie Kapichok, Gracie Fitch, Kimber Knecht.
- I would like to personally congratulate all the students who participated in the Unified Sports Bocce Program this school year. Our students enjoyed a very successful season in our second year and our hope is to continue this program in the coming years. Currently, we are looking to recruit more schools in the Northern Tier to expand this program.
- On March 15, 2019, 18 of our high school learning support students will be attending the 2019 Transition Conference at Penn College in Williamsport. This event is open to high school students in grades 10-12 who receive special education services as well as parents, guardians, and other interested parties. The event will include speakers and breakout sessions on the following three areas of Postsecondary Transition: Education and Training, Employment, and Independent Living. Mrs. Harkness and Ms. Wesneski, learning support teachers, will be the chaperones.
- On behalf of the Canton Area School District, I would like to personally thank Mr. Craig Coleman for his 12 years of service to the Canton Area School District. 12 years ago, Mr. Coleman walked into his current position new to the community, the school, and to the students he would serve. Over the past 12 years, Mr. Coleman has had to work under the tutelage of three superintendents and other administrators within the district. Anybody that knows Mr. Coleman would agree that his heart was always with the students and teachers of the CASD. Mr. Coleman's sense of wit and humor was a way in which he connected with students and teachers alike. ### **Business Manager**

Mr. Mark Jannone, Business Manager/Board Secretary, reported on the following:

- Explained that there would be a motion on this agenda to approve resurfacing the synthetic running track at state contract bid of \$142,390.
- There is an Authorization for Expenditure document to be approved for the refinishing of both gym floors at a total of \$46,000.
- The Nutrition Group has submitted their guarantee for the 2019/2020 school year which is a loss of no more than \$9,242. He explained to the board that we anticipated a significant decrease in revenue due to a reduction in our reimbursement percentage, however, we accepted the decrease in order to maintain a part of the Community Eligibility Program.
- Informed the board that because we will have 30 days between the June board meeting and the May board meeting, we intend to pass the General Fund Preliminary Budget at the May meeting. He recommended that the Finance Committee has a meeting to review the budget between April  $22^{nd}$  and May  $8^{th}$ .
