MINUTES CANTON AREA SCHOOL DISTRICT OCTOBER 8, 2020

The regular meeting of the Canton Area School District Board of Education was held on Thursday, October 8, 2020 at 5:00 p.m. in the Canton Jr/Sr High School Cafeteria.

MEETING CALLED TO ORDER

Our President, Mrs. Judy Sourbeer, called the meeting to order, welcomed all in attendance, and reminded the audience to please sign in if they had not done so.

All stood and recited the Pledge to the Flag.

REPORTS

Superintendent

Dr. Eric Briggs, Superintendent, reported on the following items:

- The Governor amended the order for spectators at indoor and outdoor events. We are excited to announce that we will be making the adjustments to our athletic health and safety plans to allow additional spectators and students at our athletic events. We will now be able to have 500 spectators at our outdoor events and with the current structure for volleyball, feel comfortable with allowing about 108 individuals into these events. This will allow both home and visitor spectators for all sporting events.
- When forced to transition to a fully remote style of education, our staff accepted the challenge and have been making the most of our early efforts to be prepared in the event that this occurred. Our staff continues to provide education and support to all students at a level that makes me proud to be on this team. We are looking forward to our return to the building on 10/13/20 and will jump right back into the excitement of homecoming week beginning on that same day!
- Students were provided with the Safe2Say Something refresher training earlier this month. The PA state mandated program allows for students to anonymously report their concerns to be addressed by administration and mental health professionals, as well as, law enforcement if necessary.
- The elementary school has handed out over 150 Chromebooks for students so they are able to participate in our online learning platform at the elementary school.
- Mr. Darryl Jannone will be conducting our safety drills next week with our elementary students in order for the district to stay in compliance with requirements set forth through Act 44.

- Elementary teachers will be participating in a pilot program called SCREEN in order to continue to get ideas on how to improve our Tier I and Tier II PBIS supports at the elementary school.
- As an alternative to the PSSAs/Keystones, the Pennsylvania Alternative State Assessment (PASA) was given to students with profound academic needs. The new venue for Alternative Testing is now called Distant Learning Map. The learning map model helps parents and educators guide students to success by showing them where a student is now, where the student has been, and where the student is going. As a result of the tests, students will fall under the following categories: Initial Precursor; Distal Precursor; Proximal Precursor; and Target. These categories will replace the prior categories of: Emerging: Novice; Proficient; and Advanced. We expect 15 to 17 students to be enrolled for the Distant Learning Map Testing.
- Due to the school closure from March 13, 2020 to the end of the 2019/2020 school year, the students' IEP goals/skills have been assessed to determine if there was a regression with aforementioned goals/skills. If regression occurred, remediation will be implemented until December 2, 2020, at which time another assessment will take place to determine if COVID Compensatory Services (CCS) is required. If the assessment indicates regression, continued remediation would occur during the school day until the skill is demonstrated.
- Thanked Michelle Ward for her 18 years of service in the Canton Area School District. Michelle has had many different job duties in her 18 years with the district. She has done a great job in many of the day-to-day operations that occur at our high school. Her knowledge and expertise will be missed immensely and we wish her the best of luck as she moves forward in a different direction with her career path.
- Acknowledged that last week Canton lost a pillar of the community in John Shaffer. John spent
 countless hours covering the happenings within the Canton Area School District. No matter what
 the situation, John always seemed to have a positive attitude toward the coverage he did for the
 district and was always willing to come on short notice to cover the students and faculty in the
 district. Thanks John for everything you did to support our district and our community through
 your work at the Canton Sentinel.
- PSBA Board Presentation It was anticipated that a representative from the PSBA would be virtually present to present Ryan Allen with an Honor Roll Certificate for eight years of school board service. Unfortunately, the representative was either unable to virtually attend or thought the meeting was at a different time.
