### **REPORTS**

### **Superintendent**

Dr. Eric Briggs, Superintendent, reported on the following items:

- It is with great sadness that I report to you this evening the passing of Mr. James McNaul. Jim taught business and accounting and in 1983 he became the Director of Guidance where he proudly mentored students until 1993. He was a member of Canton Area School District Board of Directors for eight years. He officiated football and wrestling in the Northern Tier for over 20 years. For those that knew Jim, he was a very active person during his personal life and throughout his community. Please know that the district's thoughts and prayers are with Jim's family at this time.
- As you may have heard the PDE has required school districts to sign an Attestation Form where superintendents and board presidents were required to attest to agreement with following all of the Department of Health and PDE health and safety recommendations, the newest mask order, and the school closure matrix. This was a requirement from the state in order for schools to be allowed to provide in-person instruction. Mrs. Sourbeer and I completed the attestation form and I submitted the document prior to its deadline which was Monday along with 99% of schools across the Commonwealth. It's important to understand that as a result of the attestation, Canton is agreeing to all of the Department of Health guidelines. Additionally, information that was previously promoted as Department of Health recommendations has now become requirements. As I navigate this challenging landscape, it is important to note that the information I receive from the Department of Health or PDE is continually changing. By signing the attestation form, future changes from the state will need to be implemented immediately. The state requirements establish the minimum expectation, sort of the foundation or base level for pandemic mitigation efforts. However, there are circumstances that may dictate the need for me to respond quickly to circumstances including the possibility of enacting a school closure even before meeting the minimum requirements. The attestation form requirements seem to have lessened the flexibility and decreased the amount of local control associated with school operations. As a result, it is clear to me that pivoting between remote-instruction and in-person instruction may become more frequent.

- On November 17, 2020, the Department of Health updated the order on wearing face coverings at indoor and outdoor public places and maintaining social distancing. Also see the PDE's updated FAQ on face coverings in schools and during athletic events.
- The Department of Health updated the maximum capacity calculator for both indoor and outdoor events maximum occupancy calculator for indoor and outdoor events:

Allowable Indoor Rate by Maximum Occupancy – ELE - 108 x 6 = 648 = 65; HS - 87 x 6 = 522 = 53 28 x 6 = 168 = 17

0 - 2,000 people: 10% of Maximum occupancy Allowable Outdoor Rate by Maximum Occupancy

0 – 2,000 people: 15% of Maximum Occupancy

- From December 1<sup>st</sup> through December 3<sup>rd</sup>, the district has had to quarantine 15 students and staff and has had four confirmed cases (two staff/two student).
- Congratulations to our Volleyball team for winning their fourth straight District IV title and winning their first round state playoff game to eventually fall in the state quarterfinals. Congratulations to our football team for an undefeated season and a tough loss in the District IV football championship game against Muncy. Congratulations to those who were able to participate in the District IV Cross Country meet and to those that could have but were prevented due to quarantine. All three teams had to endure the loss of teammates due to quarantine multiple times throughout the season and deserve recognition for how they handled tough situations the Warrior Way!
- While Covid-19 prevented us from holding our annual Veteran's Day assembly as normal, we were able to improvise and pay tribute to our community veterans with a virtual ceremony. The ceremony was developed and lead by our student government group, along with their advisor, Brandy McRoberts, and included students speaking, the playing of our national anthem sung by our chorus class, Taps played by Curtis Lammy and ending with the presentation of our customary Veteran's Day wreath in the front of the school memorial.
- Our annual National Honor Society induction ceremony was taped and "aired" on our website on November 20, 2020 at 6 p.m. Four of our current seniors, along with 18 current juniors, were inducted during a ceremony designed and implemented by both the NHS officers and Mrs. Segur. The ceremony is archived on our district website and can be viewed for the next twelve months.
- We are working through online learning with students, parents, and staff through December 4, 2020. Every student was assigned a Chromebook to take home and use for remote learning.
- Due to the school closure from March 13, 2020, to the end of the 2019/2020 school year, the students' IEP goals/skills have been assessed to determine if there was a regression with aforementioned goals/skills. We have found 28 learning support students who have regressed on their goals during the above time period. The Learning Support teachers have worked hard in assisting the students the last several months in recovering their regression. Out of 28 students, we now only have one student who still requires extra services (CCS) to regain lost skills (this is in the area of physical therapy). The CCS will take place for the student during school hours in accordance with the schedule of the physical therapist.

At this time, Dr. Briggs introduced Autumn Alleman, PSBA Member Services Manager, who presented Mr. Ryan Allen with a Certificate of Appreciation for his years of service.

## **Business Manager**

Mr. Mark Jannone, Business Manager/Board Secretary, reported on the following:

- Transportation Funding The bill provides some clarity regarding pupil transportation payments to be made during the 2021/2022 fiscal year. In 2021/2022, the language provides that school entities will receive the greater of either 1) what this year's formula data would drive out to them (i.e. the normal process) or 2) what they were allocated for this fiscal year (2020/2021). To receive what they received in the prior fiscal year (again the amount allocated for this fiscal year), the school entity must continue paying school bus transportation contractors, even when transportation is not provided. The amount to be paid to them will be calculated based on what they would have received had the pandemic not occurred minus variable costs, which will be defined and determined by PDE in consultation with PASBO, PSBA, and the Pennsylvania School Bus Association. This guidance will be provided with 30 days of the effective date and school bus contractors must certify the amount of the variable cost reduction to school entities.
- Thanked Tops Market for donating the bags for our meal distribution.
