# MINUTES CANTON AREA SCHOOL DISTRICT MAY 13, 2021

The regular meeting of the Canton Area School District Board of Education was held virtually on Thursday, May 13, 2021 at 5:00 p.m.

## MEETING CALLED TO ORDER

Our President, Mrs. Judy Sourbeer, called the meeting to order, welcomed all in attendance, and reminded the audience to please sign in if they had not done so.

All stood and recited the Pledge to the Flag.

#### **REPORTS**

# Superintendent

Dr. Eric Briggs, Superintendent, reported on the following items:

• This past weekend, the Canton education community lost an educational leader that impacted the lives of thousands of students and adults within the walls of our school and the local community, Dr. Robert Jannone. As I have spent a little bit of time visiting with him many months ago and learning about him through some of our current staff and his family, I began to understand how he was a leader ahead of his time. One of the stories Dr. Jannone shared with me involved a dance that he wanted to host at the school but concerns had arisen due to the behavior of some of the students and fear for what they may do if this dance moved forward. Through his leadership lens, he quickly realized how important it was for these students to have an active role (and to feel like they were needed and important in this situation) in order for this event to be successful. He was able to support this group of students and pull the dance off without a hitch (utilizing his resources

to support those students who needed them the most). We will be forever grateful for the work he did for our school and community. As I learned this week, when Dr. Jannone's name is brought up in conversation, one of the first thing everybody thinks about is his belief (and start of) Warrior Pride! Dr. Jannone, your family is in our thoughts and prayers, and thank you for exemplifying through your leadership, the Warrior Way!

- Last week the Wolf administration, in coordination with the COVID-19 Vaccine Joint Task Force, announced that mitigation orders, except masking, will be lifted on Memorial Day. The current order requiring Pennsylvanians to wear masks will be lifted when 70% of Pennsylvanians age 18 and older are fully vaccinated. Face coverings are required to be worn indoors and outdoors if you are away from your home. In accordance with the latest Centers for Disease Control and Prevention (CDC) guidance, fully vaccinated Pennsylvanians are not required to wear a mask during certain activities. Requirements such as testing and reporting new cases will remain in place for hospitals and long-term care facilities. The Department of Health recommends that Pennsylvanians refer to CDC guidance and recommendations regarding ongoing COVID-19 safety measures and procedures. The governor's Proclamation of Disaster Emergency for the COVID-19 pandemic remains in place. As of May 6<sup>th</sup>, about 51.2% of Pennsylvanians had received their first vaccine dose.
- Graduation is currently scheduled for June 4<sup>th</sup> at 6 p.m. on the football field with rain dates scheduled on June 5<sup>th</sup> or June 7<sup>th</sup>, if necessary. The senior parade will follow the ceremony and proceed through town. The parade route, as well as details regarding graduation, are described in the Guide to Graduation documents.
- The CHS Senior Athletic and Academic Awards ceremonies are scheduled for May 18<sup>th</sup> and May 25<sup>th</sup>, 2021, respectively. We will be recognizing our top senior athletic and academic award winners. The events will be held in the CHS auditorium and allow for students, presenters, and two parents to attend in-person. The events will also be live streamed for those without tickets to view.
- Our Guidance Department has been working hard to help students register for their 2021/2022 courses. We are on track to have the student schedules completed and available to students and parents before we leave for summer vacation.
- The PSSA examinations are currently being conducted for all 7<sup>th</sup> and 8<sup>th</sup> graders. On our first day of PSSA testing (5/10/21), 98% of the 7<sup>th</sup> and 8<sup>th</sup> graders were present to complete the exams. As a side note, we did have eight students quarantined and unable to complete the exams which reduced our actual participation to 92%.
- 6<sup>th</sup> grade graduation will occur outdoors this year on June 1<sup>st</sup>.
- The awards assembly for our elementary students will also occur on June  $2^{nd}$  with the final PBIS Assembly on June  $3^{rd}$ .
- 6<sup>th</sup> and 7<sup>th</sup> grade transition meetings will occur May 19<sup>th</sup> and 20<sup>th</sup>.
- Thanked the parents who donated a popcorn bar for our students during the PSSA testing week. We appreciate this thoughtful gesture and it shows another way our parents stay engaged with our student learning.
- Eight learning support students will receive their high school diplomas this year. We extend our sincere appreciation to all of our wonderful learning support teachers and paraprofessionals who have assisted these students through the years to reach their goal of graduation.
- Two students from our Supplemental Learning Support classroom are involved with Canton's School to Work program through the auspices of OVR (Office of Vocational Rehabilitation), and three students from that classroom that work in the school's cafeteria each day. The purpose of the work program is to provide the students with work experience and to aid in their work ethics development. This fall we hope to get more students back in the community for their work experiences.
- Recognized the professional staff who will be retiring at the end of the 2020/2021 school year:
  - Becky Roof has served as a special education teacher in the district for the last 25 years. She has been a critical part of our special education department at the elementary school. Some of the most critical years of a child's life, from an educational perspective, are in the kindergarten through 6th grade years. Becky has spent about 33,000 hours in our elementary school providing services to our neediest children. She has spent countless hours outside of the classroom supporting these same students through the Special Olympics program. Becky came in every day, gave 100% each and every day, and was a model professional each and every year. Every school district wishes they had a Becky Roof. We were fortunate to be part of her professional life for 25 years.
  - Another great asset of the Canton Area School District has been Claire Waldmeyer. We've had the pleasure of working with Claire for 17 years, and she spent an additional 10 years prior to that as a substitute for the district. Claire would be described by her peers as a professional who was diligent with her work, always considered the needs of the students first, and would

always do her best to embrace change. As the superintendent, one of my favorite characteristics that Claire has is the way she tackled the technology challenges teachers have faced over the past few years. Claire was not always the most technology savvy teacher, but she was always willing to grow professionally and learn as much as she could to become a better teacher through technology integration. I applaud her for this work, specifically during a time that was late in her career. Claire will be greatly missed by the students and staff.

- Danielle Gallagher has been the Spanish teacher for Canton Area School District for the past 11 years. One of Danielle's greatest strengths is her ability to build relationships with students and provide them challenging content in a way that students could struggle through the learning process but become more affluent speakers of the Spanish language through her daily lessons and activities. Danielle was always seeking ways to improve her teaching craft and was very supportive of all learners who entered her classroom. It is unfortunate that we were only able to be part of her professional career for 11 years, but we will cherish those years.

# **Business Manager**

Mr. Mark Jannone. Business Manager/Board Secretary, reported on the following:

- The final budget is expected to be passed at the June 10<sup>th</sup> board meeting and it's anticipated to contain the following expenses that were not previously discussed:
  - Instead of entering into a five year lease we will do an outright purchase of all new copiers and printers for approximately \$121,000 which is expected to save the district approximately \$105,000 over five years.
  - Purchase of a new maintenance/lunch truck approximately \$50,000.
  - Pavement milling and refinishing, mainly around the elementary school approximately \$145,000.
  - A recommended transfer of \$750,000 to a newly established Capital Reserve account.
