Dr. Eric Briggs, Superintendent, reported on the following items:

- House Resolution 15 (Rep. Owlett, R-Tioga) which directs the Joint State Government Commission to conduct an analysis of the current school bus driver industry and provide recommendations about how to address the shortage of bus drivers.
- Per PDE regulations, the district health and safety plan must be board approved, posted to our website, and be written in a manner that is understood by the public by July 30, 2021 so we will be assured to received our ESER III funds. This plan was crafted by our administrative team and reviewed by the district's pandemic team. We will continue to monitor and adjust the plan as needed throughout the summer. Please note that we must also review the plan every six months through September, 2024. Our district will use our Safe School Committee (which also includes our Pandemic Team) to address this need.
- The class of 2021 ended their year of "ups and downs" with commencement outside on the football field last Friday evening. Everyone involved including the students, maintenance staff, IT staff and community members helped to make this a special ending for our seniors. 2021/2022 Final Budget

The final budget would set taxes at the following rates:

The following tax levies remain the same as last year:

Occupation Assessment Tax: 200 mills (Bradford County System)

Category 1 = \$ 0	Category $2 = 15
Category 3 = \$30	Category $4 = 60

Earned Income Tax: 1% levy (.5% effective rate due to sharing)

Real Estate Transfer Tax: 1% (.5% effective rate due to sharing)

Per Capita Tax per School Code 679: \$5 per person

Per Capita Tax Act 511: \$10 per person levy (\$5 effective rate due to sharing)

Discounts and Penalties: Occupation, Per Capita, and Real Estate taxes will be subject to a 2% discount if paid within two (2) months of the bill date and a 10% penalty if paid after four (4) months of the bill date.

There will be no discount or penalty for payments made between two (2) months and four (4) months of the bill date.

A three (3) month installment plan is available. Payments will be due on August 31st, September 30th, and October 31st.
