## REPORTS

## Superintendent

Dr. Eric Briggs, Superintendent, reported on the following items:

- More updated guidance from the CDC (from AASA, August 5) The Centers for Disease Control and Prevention (CDC) updated the Guidance for COVID-19 Prevention in K-12 Schools to align with CDC's existing guidance for fully vaccinated people and assist K-12 schools in opening for inperson instruction and remaining open. Additionally, the Considerations for Case Investigation and Contact Tracing in K-12 Schools and Institutions of Higher Education (IHEs) has been updated to align with new CDC guidance. CDC's Guidance for COVID-19 Prevention in K-12 Schools includes recommendations for:
  - Promoting vaccination among teachers, staff, families, and eligible students.
  - Universal indoor masking for all teachers, staff, students, and visitors to K-12 schools, regardless of vaccination status.
  - Implementation of layered prevention strategies to reduce the spread of COVID-19 in schools, including maintaining at least 3 feet of distance between students within classrooms in combination with universal masking; screening testing to promptly identify cases, clusters, and outbreaks; handwashing and respiratory etiquette; cleaning and disinfection; and contact tracing in combination with isolation and quarantine.
- We are in the final stages of reopening the school for our students and staff toward the end of the month. We will begin having new staff back in the buildings on Monday, August 23<sup>rd</sup> for the New Teacher Induction. Our first in-service day is Tuesday, August 24<sup>th</sup> followed by an Act 80 day on Wednesday August 25<sup>th</sup>. The focus of the training on our Act 80 day will be on restorative practices,

guided reading, and co-teaching. Finally, we will welcome the students back to our campus on Thursday, August 26<sup>th</sup> for the first day of school.

- I would like to extend a Warrior welcome to Kelsey Herman. Earlier this week, Kelsey was chosen by our interview committee to be the new high school social studies teacher. We are excited to have her on board as part of our Warrior family.
- I would like to publicly acknowledge the retirement of Helen Kilbourn. Helen was a staple in our paraprofessional department serving the students in the Canton Area School District for 19.5 years. She was always caring, compassionate, and willing to work with any and all students, no matter what diverse need they brought to the table. She will be greatly missed by all students and staff, specifically the students and staff in Mrs. Barr's room. We wish her nothing but the best of luck and great health in retirement.
- As we move closer to the upcoming school year, you will notice the hard work of our custodial and maintenance staff as you look at the hallways, classroom floors, and numerous newly implemented safety and security features. I'd like to thank all of the staff for an amazing job this summer getting ready for our return to school!
- Mr. Rockwell and I have been in constant communication with NTL Athletic Directors, Principals and Superintendents to continue to adapt to the changes and recommendations announced by the CDC. At this time, we have had our band camp, as well as a full week of official practice for football and look forward to all of our extracurricular activities beginning next week.
- Specific staff at the elementary school will be participating in QBS training on August 19<sup>th</sup>.
- Kindergarten Orientation is on August 23<sup>rd</sup> from 5:30 p.m. to 7:30 p.m. for all incoming kindergarten students and their parents.
- I would like to formally introduce Mrs. Amy Repard as our new special education supervisor. She has hit the ground running and we are excited to have her as part of our administrative team.
