# MINUTES CANTON AREA SCHOOL DISTRICT OCTOBER 14, 2021

The regular meeting of the Canton Area School District Board of Education was held in the Canton Jr/Sr High School Auditorium on Thursday, October 14, 2021 at 5:00 p.m.

#### **REPORTS**

## Superintendent

Dr. Eric Briggs, Superintendent, reported on the following items:

• Last week, area superintendents met with the Pennsylvania Department of Education to express concerns over the mask mandate and the tremendous pressure that the mandate has placed on school board directors and superintendents. They stressed how this issue alone has fractured many relationships that took years to create with some families and other community stakeholders. Superintendents were reminded that over the next couple of weeks the Department

of Health and PDE will be closely analyzing data to look at next steps around the mask mandate moving forward. Dr. Briggs stated that it is important for our board and the community to be aware that an announcement is expected from the Department of Health and the Governor's office around November 1st.

- PDE has asked school districts to provide statistical data to them on a weekly basis rather than reporting to them on a case-by-case basis. Effective tomorrow, each district in the Commonwealth will be required to complete a short survey and submit it to PDE by 5:00 p.m. each Friday. This data will include the cases and close contacts by building. Finally, the PDE and Department of Health will be able to analyze data at the district level rather than just by county. Mr. Briggs stated that he feels that breaking the data down by district, and not just by county, is a step in the right direction.
- As of the end of school yesterday, the Canton Area School District has had 30 COVID-19 cases (10 high school and 20 elementary) and 133 close contacts (36 high school and 97 elementary).
- In light of concerns around the district's health and safety plan as it pertains to the mask mandate, the district has been following multiple court cases around the area of parents and community members challenging the mask order through the court system. In one case, the federal judge (locally) favored the district in supporting the continuation of following the mask mandate. In two other state cases, the judges have ruled in favor of school districts with the continuation to follow the mask mandate.
- Our students in the high school were able to experience an amazing homecoming week packed with fun filled activities. Students participated in spirit week, attended the parade and football game, and held a dance. Congratulations to Alexis Baldwin and Cooper Kitchen for being crowned this year's homecoming king and queen.
- This week we administered the PAYS Survey. The survey is conducted with school students in the 6th, 8th, 10th and 12th grades to learn about their behavior, attitudes, and knowledge concerning alcohol, tobacco, other drugs, and violence. The Pennsylvania Youth Survey, or PAYS, is sponsored and conducted every two years by the Pennsylvania Commission on Crime and Delinquency. The data gathered in PAYS serve two primary needs. First, the results provide school administrators, state agency directors, legislators, and others with critical information concerning the changes in patterns of the use and abuse of these harmful substances and behaviors. Second, the survey assesses risk factors that are related to these behaviors and the protective factors that help guard against them. This information allows community leaders to direct prevention resources to areas where they are likely to have the greatest impact. This year, the district will also be participating in a pilot program with our 4th grade class.
- The elementary school has been implementing our Guided Reading Program in grades K-6 with coteaching. Earlier this week, the elementary teaching staff had the opportunity to complete their Act 13 Teacher Observation Framework training.
- Our elementary teachers continue with a book study titled, "I Wish My Teacher Knew."
- The district purchased 135 iWave devices with ESSER funds. These air ionizers are installed directly in the air handling units throughout the buildings to eradicate any and all airborne contaminates as they pass through the air handling units. The installation of these units has been a priority of the maintenance crew and they are nearly all installed.
- Our local firefighters came to campus last week for Fire Prevention Week to educate our kindergarten and 1st grade classes. Our students really enjoyed this activity and we appreciate the willingness of the fire department to support the school each year.
- Our special education department is busy gathering data for our upcoming December 1 count for the year. We currently are working through finding coverage for many of our students who are unable to receive support from outside agencies. Mrs. Repard continues to check in each week to see what progress they have made in this area, and furthermore limits our resources in other areas of the educational system.
- This month the Canton Area School District is in a "tab war" with the school district ten miles north. The purpose of this tab war is to collect as many soda can tabs as possible to be sent off to the Ronald McDonald House to support children struggling with health conditions. The two districts partnered with Kids Can't Fight Cancer Alone. This non-profit organization provides support and resources to children, and their families, who are battling childhood cancer.
- Reminded the public of a couple important announcements before moving forward with the meeting:
  - For those individuals who would like to speak on agenda or non-agenda related items, per Canton Area School District Policy #903, only residents or taxpayers of the school district are permitted to speak at Canton Area School District board meetings.
  - All individuals in the audience please continue to follow the district's health and safety plan and keep masks on throughout the meeting.

• Introduced Mr. Ron Cole, Pennsylvania School Boards Association Section 3 Advisor. Mr. Cole presented two very special awards to Mr. Eric Anderson and Mrs. Judy Sourbeer.
